This process is ongoing and comments have been provided to the agency regarding draft information regarding the authorization and process. Uncertain on actual MNR timing on the finalizing of the permit. Question – will an ESA permit for Blanding's Turtle be required by the MNR. Answer - The agency has indicated that this permit is not required for this species.	Action
4.	Regulatory process next steps: Algonquin indicated again that the Renewable Energy Approval and the ESA permit are not the only government authorizations for the project. Other authorizations will be required (to name a few - i.e. Land Tenure for dock and submarine cable, Ministry of Transportation encroachment permits, Conservation Authority Permits, Navigable Waters (Department of Fisheries and Oceans), Aeronautical Clearance (Transport Canada)	None
