Review of Submitted Questions (CWG #5)	
Windlectric provided the CWG members with a log of all questions received by the company from members of the public from June 23 rd 2017 through July 7 th 2017. The facilitator read each of the questions aloud, and the company provided answers.	
Follow up to Question #1	
Q. Is Morven Construction still using the public ferry, contrary to commitments made in the Operations Plan and to the Community?	
A. Morven Construction is conducting other projects on the island. Can suggest the use of coloured flags to differentiate projects.	
CWG General Discussion and New Questions	
Q.1. There is current construction on the Mainland. Is it legal?	
A.1. Yes. Construction on the Island is related to the dock work. This includes an access road and a ramp for the dock. Contact has been made with the various ministries to ensure all protocols are being followed.	
Q.2. On the website, it says "recent tweets", and there is a link to send donation ideas to the Amherst Island Wind Project. A response appeared that read "this account does not exist". This seemed misleading. What is happening here?	
A.2. If you do not have a twitter account, you are able to read the Windlectric posts on the twitter feed, but you cannot post comments. If you choose to activate a twitter account, you can comment directly on Windlectric's twitter posts.	
Q.3. Could the mailout have been deemed as "junk mail" or unsolicited mail, and it was not delivered to certain mailboxes who have requested to not receive mail out this type?	
A.3. Windlectric will investigate why some residents did not receive the mailout. By this time next week, the mailing issue will be resolved. The mailbox will be resolved.	
Q.4. When will the next CWG meeting be held?	
A.4. Next CWG meeting (#7) will be held either August 10 th or 11 th and will be a conference call or an in-person meeting at the Amherst Public School depending on the amount of questions submitted,
