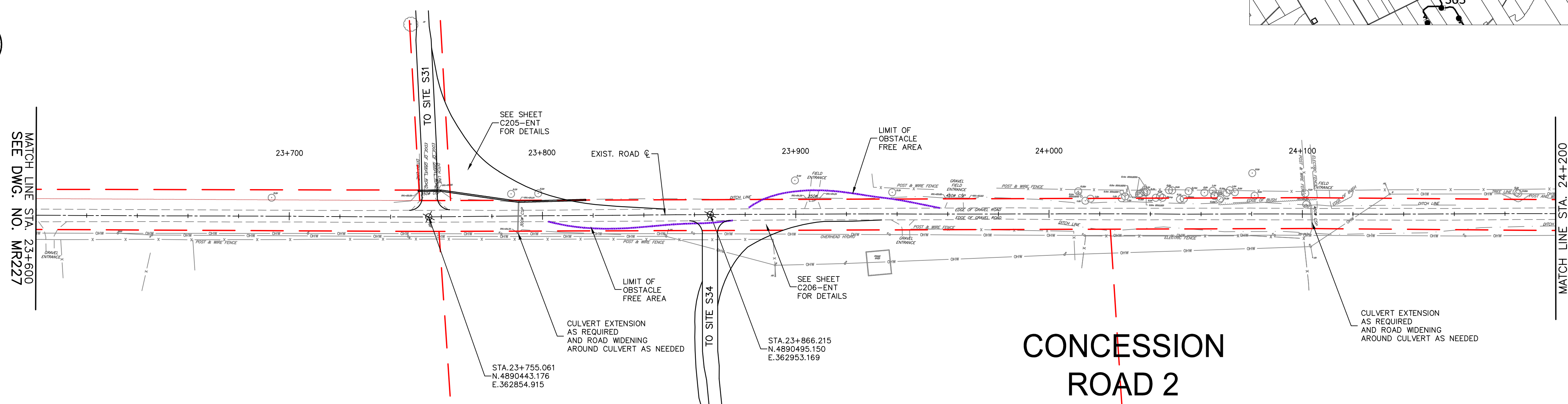
PLAN LOCATION

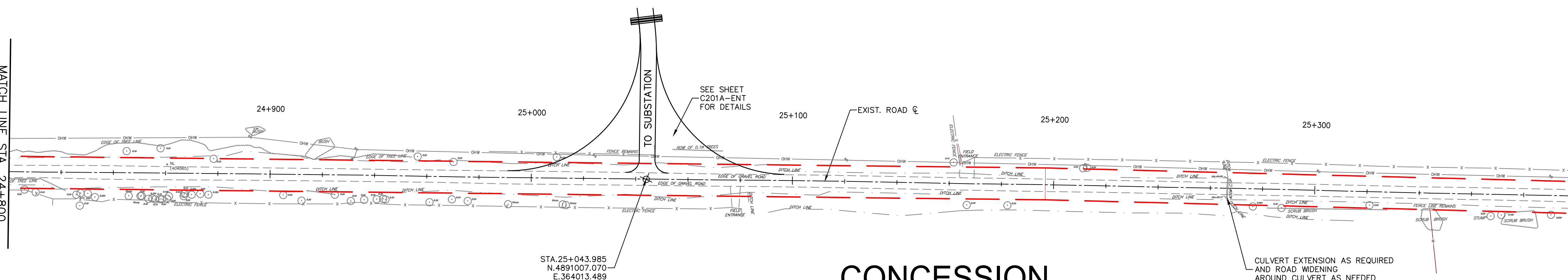
PLAN LOCATION

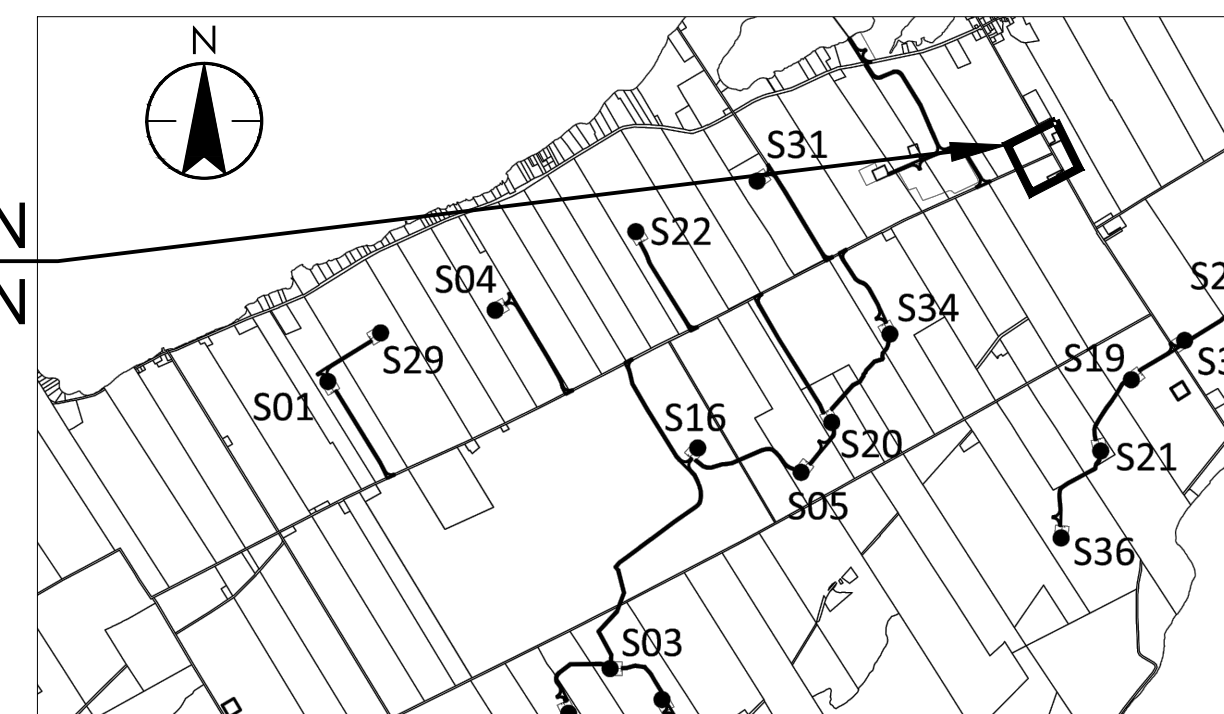

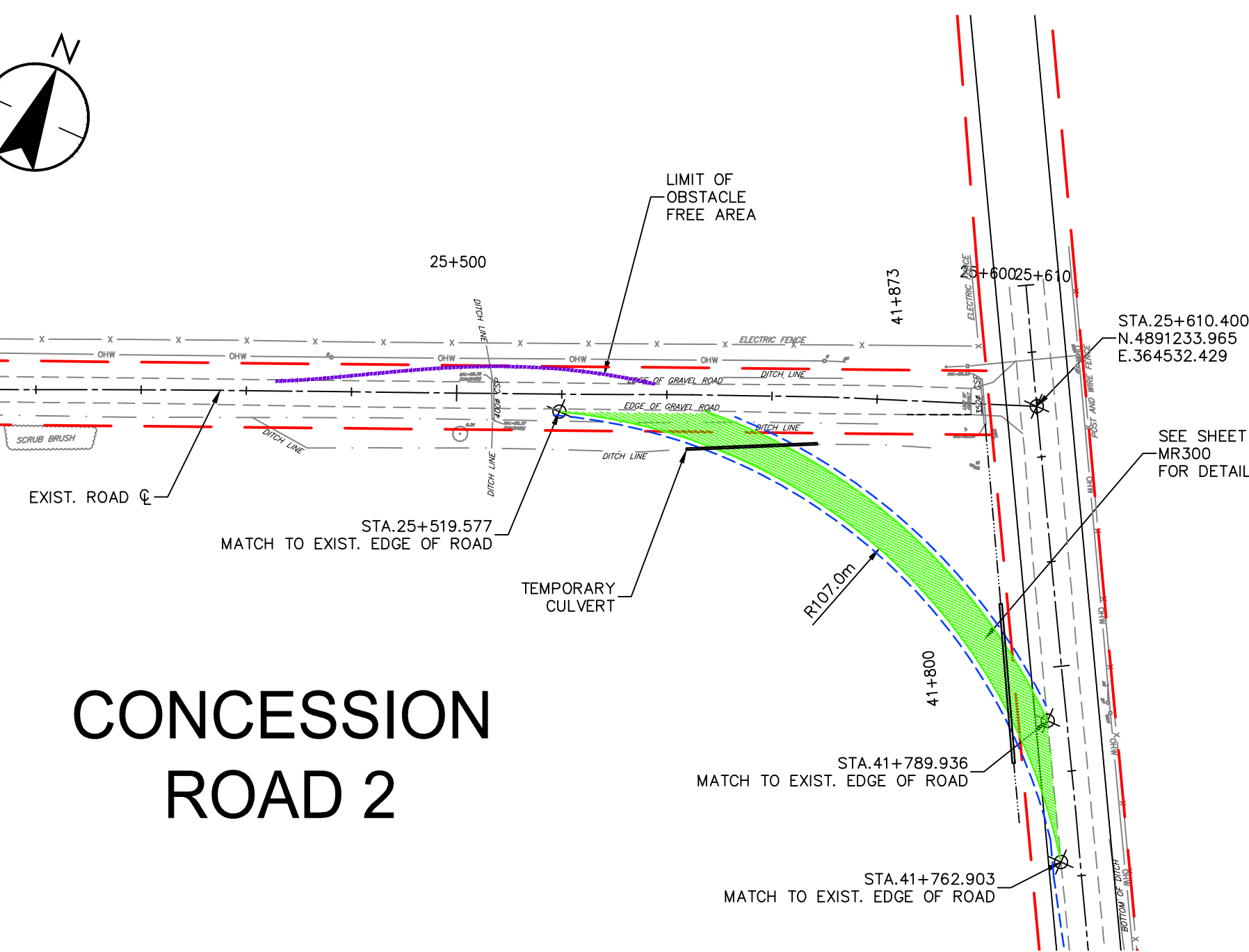
